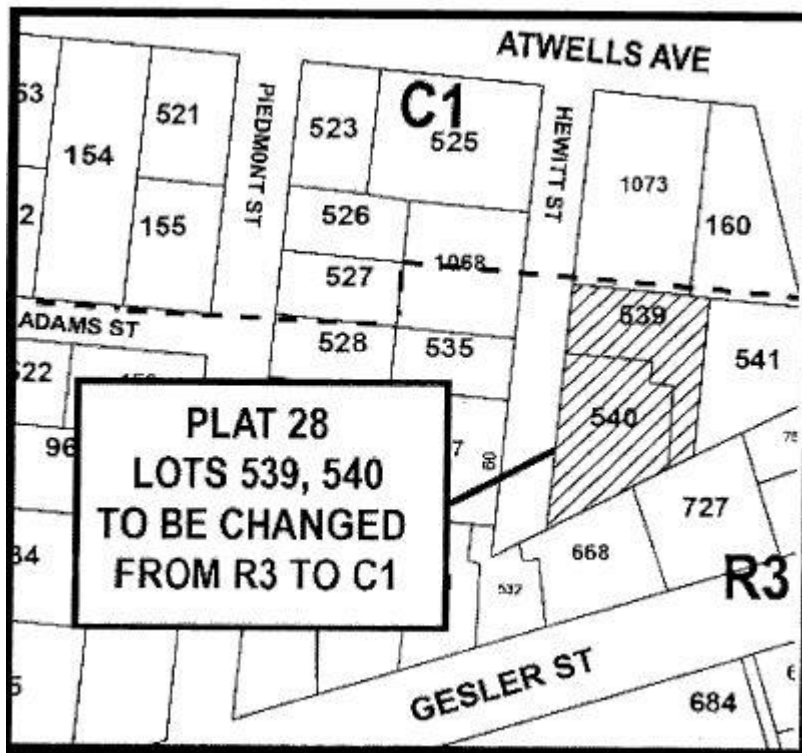


BEFORE THE COMMITTEE ON ORDINANCES

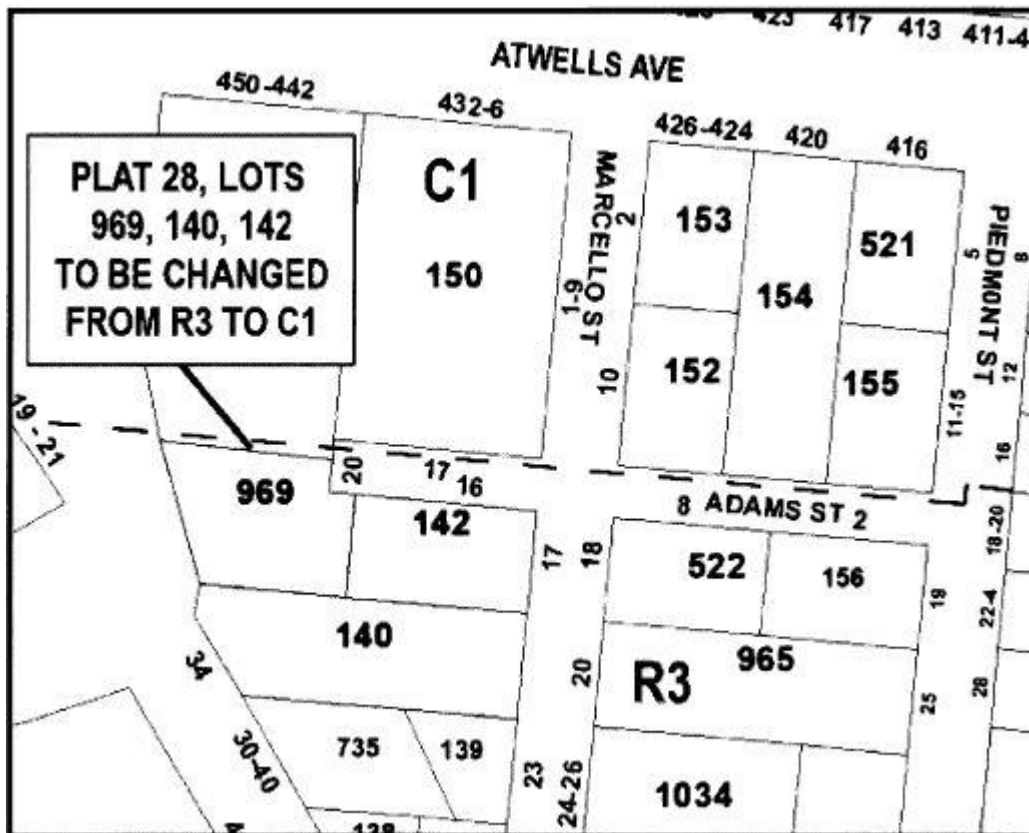
