

INSTRUCTIONS FOR COMPLETING CITY OF PROVIDENCE QUARTERLY LOBBYIST REPORTING FORM WITH EXAMPLE

Mr. Joseph Lobbeed is a lobbyist who wants to legally influence actions taken by the City of Providence and its employees. He plans to begin activities in the second quarter of 2019 and will be compensated by two groups.

Because Mr. Lobbeed is going to be lobbying on behalf of two separate groups, he must complete the lobbyist registration using the webform on the web site of the City Clerk's web site twice.

When he registers for the first client, Tobacco Trends Research, he receives his first lobbyist registration number: 90073-2019

When he registers for the second client, Chickens For Life, Inc., he receives his second lobbyist registration number: 90074-2019

Now Mr. Lobbeed is a Registrant. He conducts his lobbying activities throughout the quarter (April 1- June 30, 2019) and keeps record of his gifts, contributions, expenditures and compensation for each client.

At the end of the quarter, he files his report. Before filing, he always checks to make sure the version of the filing form he has is the latest.

Period Tab: The first tab (Period) of the report asks the registrant to enter the year and select the quarter he is reporting for. It also requests a Lobbyist Registration Reference Number. He may enter **any one** of his active registration numbers into this field. He also enters his Last name, first name, and types No into the Termination Notice field, because he plans to be active in the next quarter for his clients as well. If he did not plan to be active any longer, he would have typed Yes and would have completed the Termination Notice webform on the City Clerk web site.

Gifts Tab: The second tab (Gift) of the report asks the lobbyist if (s)he has given any gift worth more than \$25 to any public official covered by the Code of Ethics of the State of Rhode Island during the reporting period to an official or employee of the City by the Registrant. A lobbyist who reports a gift larger than \$25 has not broken the law, but the official or employee who accepts it may have.

Contributions Tab: The third tab (Contributions) is for the reporting of political contributions made to any candidate for City office, any elected official of the government of the City and any official or employee of the City seeking election to an office other than a City office during the reporting period. During this quarter, the Registrant made contributions to two people meeting that requirement. The details of those contributions are entered.

NOTE: THE FOLLOWING three tabs (Compensation, Lobbying Activities and Expenditures) must be completed if the Registrant (i) lobbied; or (ii) incurred lobbying-related expenditures; or (iii) received lobbyist-related compensation on behalf of/from ANY client during this reporting period. **If registrant did not meet any of these conditions for any client during this reporting period, these three tabs are not required, and Registrant may submit report after completing the Gifts and Contributions tabs.**

Compensation Tab: The fourth tab (Compensation) must report all compensation received from clients. In this example, Registrant was paid by two clients and the details of that compensation is entered. An important column of this tab is the “On Behalf Of” field, which is required if your compensation is on behalf of a client different from that which is directly providing compensation.

Lobbying Activities: The fifth tab is for reporting the target of lobbying activities, the type of action sought, a description of the specific action sought, and to which client each activity was related. Please use your best judgment as to the Type of action sought. An example of a strictly Administrative action would be a direct request to a department to extend a contract (although if this would require legislative action, then it would be both Administrative and Legislative).

Expenditures: The sixth tab is the only tab that does not allow information to be entered for multiple clients. Duplicate tabs must be created in the same Excel Workbook immediately after the first Expenditure tab for every client that meets the requirements described in the NOTE above. This Registrant had to create one additional Expenditures tab in order to enter the details of his two clients for this reporting period. The Lobbyist Registration Number and corresponding Client Name must be entered at the top and totals for each expenditure category related to lobbying for that client (regardless of who paid for the expenditure). Finally, each single expenditure over \$25 must be detailed in the last section of this tab.

Completed lobbyist quarterly reports must be submitted using the link below in Microsoft Excel format using the template linked to the page by midnight on the 15th day of the month immediately following the end of the quarter for which the report is being filed.

Registrant must report every political contribution over \$25 made to any candidate for City office, any elected official of the government of the City and any official or employee of the City seeking election to an office other than a City office during the reporting period.

COMPENSATION

This tab must be completed if the Registrant (i) lobbied; or (ii) incurred lobbying-related expenditures; or (iii) received lobbyist-related compensation on behalf of/from ANY client during this reporting period. If registrant did not meet any of these conditions for any client during this reporting period, this tab (and following tabs) are not required, and Registrant may submit report after completing the Gifts and Contributions tabs.

If registrant met any of the conditions above for any client during reporting period, **the below and following tabs must be completed for EACH client** on whose behalf lobbying was performed, or on whose behalf lobbying-related expenditures were made, or from whom lobbying related compensation was received.

NOTE: If you submit the following sections for some but not all of your registered clients, you are presumed to be representing that you did not lobby, incur expenditures or receive compensation on behalf of/from those clients for whom you have not submitted them.

Registrant is required to enter total compensation received from the client, a list of legislative actions sought on behalf of client (Lobbying Activities tab), and a list of all single expenditures in excess of \$25 personally incurred or charged to client for each of the legislative actions sought (Expenditures tab).
